## Law No. 14/2013: Entrepreneurial Family Residence Permit Type

It is a visa required for individuals who intend to engage in innovative entrepreneurial activities that are beneficial to Spain's economic interests. Members of the same family who meet the following criteria can apply together and benefit from the investor family visa:

- 1. Spouses or registered partners (pareja de hecho).
- 2. Minor children or adult children dependent on the family.
- 3. Adult family members economically dependent on the applicant or individuals mentioned above. Required documents:
- 1. National Visa Application Form:

Complete and signed form in Spanish or English.

2. Photograph:

One biometric photograph (3 x 4 cm) with a white background.

3. Valid passport or travel document:

Original passport and a photocopy of the page with passport information. The passport should be valid for at least one year and have at least two blank pages. Passports issued more than 10 years ago will not be accepted.

4. Letter of Intent:

A letter preferably in Spanish, Turkish, or English, where the applicant expresses themselves and provides details about the purpose of the trip.

5. Positive project report:

Original and a copy of the report issued by the "Oficina Económica y Comercial" or the "Dirección General de Comercio Internacional e Inversiones" within the jurisdiction of the embassy. The report should consider the following:

- Creation of employment opportunities in Spain as a priority.
- Applicant's professional profile, education, and relevant experience related to the project.
- Business plan explaining the project, product, or service, including market analysis and financing.
- Added value, innovation, or investment opportunities it will provide to the Spanish economy.
- 6. Documents proving financial status:

Documents demonstrating that the applicant and/or family members have sufficient economic resources and a regular income. Bank statements should be signed and stamped by the bank.

7. Criminal record:

Original and photocopy of the criminal record certificate (translated into Spanish and notarized with the "La Haye" Apostille stamp). Criminal record certificates should be obtained from all countries where the applicant has resided for an extended period within the last five years. The certificate should not be older than three months.

8. Health insurance:

An insurance policy compatible with the Spanish Healthcare System and authorized to provide services in Spain. Original and photocopy.

9. Proof of residence:

Certificate of residence.

10. If the applicant is not applying in person:

Notarized authorization/Power of Attorney for the person submitting the application (translated into Spanish and notarized with the "La Haye" Apostille stamp).

11. Flight reservation.

Additional documents for family members:

If family members are applying together:

All the documents mentioned above should be submitted separately. For applicants under 18 years old, the signature sections of the forms should be signed by the parents. If spouses are applying together, a Marriage Certificate (translated into Spanish and notarized with the "La Haye" Apostille stamp) or Form B (no translation required, only the Apostille is necessary) should be provided. The original documents should not be older than three months. If applying for children, a Birth Certificate (translated into Spanish and notarized with the "La Haye" Apostille stamp) or Form A (no translation required, only the Apostille is necessary) should be provided. The original documents should not be

older than three months. Adult children and adult family members must provide proof of their economic dependency on the family.
