Education, research in public or private organisations, specified in the following cases,

the visa required to carry out development and innovation activities:

Law 14/2011 of 1 June 2011 on Science, Technology and Innovation

research staff referred to in the first additional provision and in Article 13.

Scientific research staff in commercial organisations or R&D centres established in Spain.

scientific and technical organisations to carry out research, development and technological innovation studies

Personnel.

Processed by the Large Companies and Strategic Collectives Unit and processed by the Labour and Training provided by the General Directorate of Migration of the Ministry of Social Security and residence permit for research.

Researchers are employed by public or private research organisations under an agreement if invited within the framework of the programme.

Universities, institutions or higher education and research centres established in Spain professors hired by centres or business schools.

Members of the same family who have the following characteristics can apply for this visa together can benefit:

Spouses or civil partners (pareja de hecho)

② Minor children under the age of 18 or dependent on the family.

2 Adult family members who are economically dependent on this person or persons.

Required Documents:

1. National Visa Application Form:

(Spanish or English) Completed and signed.

2. Photograph:

One biometric photograph with white background (3 x 4cm.)

3. Valid passport or travel document:

Original passport and photocopy of the page with passport details passport must be valid for at least one year.

The passport must be valid for at least one year and have at least two blank pages.

Passports older than 10 years will not be accepted.

4.Petition of Intention

The applicant expresses himself/herself and details the reason for travelling, preferably Petition in Spanish, Turkish or English.

5. Flight ticket reservation:

If the study period is less than 180 days, round-trip tickets.

If the duration of study is more than 180 days, only the return ticket.

6. Document showing the place of accommodation in Spain (Hotel reservation, rental agreement etc.)

Invitation letter and/or rental agreement with a photocopy of the tenant's identity card, hotel reservation (at least 15 days) or by the counterpart educational institution document showing the address of the accommodation organised.

7. Certificate of residence permit from Spain:

Residence permit from the "Unidad de Grandes Empresas y Colectivos Estratégicos authorisation document.

8. Documents proving the financial situation:

The applicant has sufficient economic resources for himself/herself and/or his/her family members that you have a regular source of income. Bank

The bank statements must be signed and stamped.

9. Health Insurance:

Covering the entire period of the applicant's stay in Spain (over 1 year the insurance for stays must be for a maximum of 1 year) from the Spanish company health insurance with the insurance company and receipt of payment.

10. Criminal Record:

All visa applicants who are old enough to obtain a Criminal Record original and photocopy of the document (after having a notarised translation into Spanish, "La Haye" Apostille stamp will be obtained from the Governor's Office) Long-term a registration certificate must be obtained from each country of residence, Spanish translation and "La Haye

It must be apostilled.

Registration Record must not be older than 3 months.

11. Health Report: (Required for stays over 180 days)

Original and photocopy of the medical report from a full-fledged hospital (in Spanish after the notarised translation has been made, the "La Haye" Apostille stamp from the Governor's Office

will be shot)

Health reports must contain the following statement: "Our hospital

the applicant (name of the person) is a member of the World Health Organisation International Health

In accordance with the Regulation (2005), any disease that may pose a public health risk does not exist"

The report should not be older than 3 months.

12. Certificate of Residence

Additional documents required for family members:

If family members are applying at the same time:

All of the documents listed above must be submitted separately. 18 years of age The signature sections on the forms of minors must be signed by their parents. Birth Certificate: Birth certificate for children (notarised translation into Spanish the "La Haye" Apostille stamp will be obtained from the Governor's Office) or

Formula A (No translation required, only Apostille required) Original documents 3

must not be older than one month.

Marriage Certificate: If husband and wife are applying together, a Marriage Certificate (in Spanish after a notarised translation has been made, the "La Haye" Apostille stamp from the Governorship or Formula B (no need for translation, only Apostille is required)

Original documents must not be older than 3 months.
