1. NATIONAL VISA APPLICATION FORM

(Spanish or English) Completely completed and signed.

2. PHOTO

One biometric photograph (3 x 4 cm) with a white background.

3. NIE NUMBER

4. CRIMINAL RECORD RECORD

Original and photocopy of the Criminal Record Certificate for all visa applicants of legal age (after a notarized translation into Spanish, a "Hague" Apostille stamp will be obtained from the Governor's Office).

A criminal record record must be obtained from each country of long-term residence within the last two years, with a Spanish translation and a "Hague" Apostille.

The criminal record must not be older than 3 months.

Separate apostilles are required for the original and the translation. Notarized apostilles are not accepted for the original.

5. HEALTH INSURANCE AND PAYMENT RECEIPT

Must be issued by an institution operating or authorized to operate in Spain.

Health insurance and payment receipt issued by a Spanish company, covering the entire period the applicant will be in Spain (for stays longer than one year, the insurance must be for a maximum of one year).

Must have a minimum coverage of &30,000.

6. DOCUMENTS PROVIDING REMOTE WORK AND INCOME DOCUMENTS:

000 All documents must be in Spanish. Documents proving the person will be working remotely, contracts and agreements, and the company's tax certificate and documents proving its activities must be translated into Spanish and submitted.

The diploma must also be translated into Spanish and submitted, along with the original and a photocopy.

7. Social Security Institution (SSI) SERVICE STATEMENT (IF AVAILABLE) to be translated into Spanish.

8. FINANCIAL RESOURCES

Documents demonstrating that the applicant has sufficient financial resources for themselves and/or their family members and a regular source of income. Bank statements must be signed and stamped by the bank. Bank statements for the last three months must be submitted within the last week.

9. RESIDENCE CARD IN TURKEY

11. VALID PASSPORT AND PHOTOCOPIES OF ALL PROCESSED PAGES

BIRTH CERTIFICATE: FOR CHILDREN, BIRTH CERTIFICATE (AFTER A NOTARY-CERTIFIED TRANSLATION INTO SPANISH WILL BE APPROVED WITH THE "LA HAYE" APOSTILLE STAMP FROM THE GOVERNOR'S OFFICE) OR

FORMULA A (NO TRANSLATION IS NOT NECESSARY, ONLY THE APOSTILLE IS REQUIRED). ORIGINAL DOCUMENTS MUST NOT BE OLDER THAN 3 MONTHS.

MARRIAGE CERTIFICATE: IF HUSBAND AND WIFE ARE APPLYING TOGETHER, THE MARRIAGE CERTIFICATE (AFTER IT IS NOTARIZED INTO SPANISH, THE GOVERNOR'S OFFICE WILL HAVE THE "LA HAYE" APOSTILLE STAMPED) OR FORMULA B (NO TRANSLATION IS NOT NEEDED, ONLY THE APOSTILLE IS REQUIRED) ORIGINAL DOCUMENTS MUST NOT BE OLDER THAN 3 MONTHS.
